On 8.22.21, a La Cima staff member tested positive for COVID-19. The Pima County Health Department has been notified of the case. The staff member was last on site and in classes on Friday, August 20, 2021 and has been off campus since that date. Anyone identified as a close contact of the positive individual will be notified by Pima County Health Department. A close contact is defined by the CDC as anyone who was within 6 feet of the positive individual for more than 15 minutes over a 24-hour period.

As a reminder, please continue to follow recommended mitigation protocols to protect yourself and others:

- All students, staff, parents, and visitors must wear a mask when inside any Amphi district buildings or busses.
- Remain 6 feet away from others when feasible.
- Wash your hands frequently.
- Stay home if you are sick with symptoms, including, fever, loss of taste or smell, cough, muscle aches, sore throat, shortness of breath, chills, headache, gastrointestinal symptoms such as nausea/vomiting, diarrhea, loss of appetite.
