On February 28, 2021, a student reported testing positive for COVID-19. The individual was last on campus on February 19, 2021. The Pima County Health Department has been notified of the case. A close contact is defined by the CDC as anyone who was within 6 feet of the positive individual for more than 15 minutes over a 24-hour period.
