# H. Receipt of July 2013 Report on School Auxiliary and Club Balances

Board Book information: Arizona Revised Statutes §15-1121 and 15-1125 provide for the operation of Student Activity and Auxiliary Operations funds, respectively. The Uniform System of Financial Records for Arizona School Districts (USFR) outlines procedures to be followed by school districts in the disbursements of monies from either of these funds. One requirement for the operational compliance is to provide a report to the Governing Board summarizing the transactions for the month.

The Governing Board received the Monthly Report on School Auxiliary and Club Balances for month-end July 31, 2013, as submitted (Exhibit 4, pp. 1-8).

## I. Out of State Travel

Out of state travel was approved for students and staff (source of funding indicated): from Ironwood Ridge High School to take 17 students from Yearbook/Newspaper to Boston, Massachusetts, November 13-17, 2013 (tax credits, gifts and donations, and student activity funds); from Ironwood Ridge High School to take 35 students from the Encore Show Choir to Anaheim, California, March 19-23, 2014 (tax credits and student activity funds).

Out of state travel was approved for staff (source of funding indicated): from Ironwood Ridge High School to attend the Council for Economic Education's (CEE) National Conference in Baltimore, Maryland, October 1-3, 2013 (gifts and donations funds designated for staff development and the T.R. Brown Foundation); from Canyon del Oro High School to attend the International Baccalaureate Workshop in Los Angeles, California, October 18-21, 2013 (federal funds designated for staff development); from Canyon del Oro High School to attend the National Interscholastic Athletic Administrators Association (NIAAA) National Conference in Anaheim, California, December 13-17, 2013 (auxiliary and site M & O funds designated for staff development); from Interscholastics to attend the National Interscholastic Athletic Administrators Association (NIAAA) National Conference in Anaheim, California, December 13-17, 2013 (site M & O funds designated for staff development).

# J. Approval of Superintendent's Declaration of Curricular and Instructional Alignment to the Arizona Academic Standards

Board Book information: In 1996, the Arizona State Board of Education began adoption of the Arizona Academic Standards (Standards) in the subject areas of reading, writing and mathematics. The Standards were mandated for

all Arizona public schools to implement through curriculum and instruction. Since that time, the State Standards have been modified and, more recently, Common Core Standards have been adopted.

Each year since adoption of the State Standards, school districts and charter schools have been required to verify their compliance with the Standards by submission of certain declarations of curricular and instructional alignment to the Arizona Academic Standards ("Declarations").

Compliance with this requirement establishes evidence that the Arizona Academic Standards have been incorporated into the curricular and instructional practices at the local level, in furtherance of the federal No Child Left Behind Act and AZ LEARNS. The Superintendent's Declaration, a copy of which is attached, is essentially a form of affidavit or oath of compliance with the Standards.

The Declarations actually consist of three separate documents to be signed, respectively, by the Governing Board as a body, the Superintendent as an individual, and every school principal as an individual. The Governing Board and Superintendent's Declarations are due on October 15th. The school principals' declarations will be due on February 4, 2014. For a school and district to be in compliance, all three forms of Declaration must be signed and returned to the ADE.

The Administration has also informed Principals of the content of their individual Declarations which they will sign later this year, so that they may take necessary actions during the course of the year to ensure they can truthfully make the Declaration.

The Governing Board approved the Superintendent's Declaration of Curricular and Instructional Alignment to the Arizona Academic Standards and is submission to the Arizona Department of Education (Exhibit 6).

# J. Approval of School Facility Board (SFB) FY 2014 Capital Plan

Board Book information: Per A.R.S. §15-2041 C., districts are required to submit a Capital Plan to the SFB by September 1, 2013 and request monies from the New School Facilities fund if the Plan indicates a need for a new school or addition to an existing school within the next four (4) years (through FY 2018), or a need for land within the next ten (10) years (through FY 2024).

The Governing Board approved the FY 2014 Capital Plan and its submittal to the SFB (Exhibit 5, pp. 1-2).

# **K. Award of Contract for Bus Services Based upon Responses to Request for Bid (RFB) 15-0004** Board Book information:
