Principal's Report: Mr. Munger

- Virtual Open House
 - Approximately 76 to 80 families joined, which represented approximately 150 views.
 - \circ $\;$ The event was well received by those attending.
 - The next event is planned for January 27, 2021.
 - The school will send information on the event to all middle schools in the district/area and not just to schools that feed into IRHS.
- Pima County Covid-19 Metric Report
 - The most recent metric report indicated one (1) yellow metric and two (2) red metrics.
 - It is likely the district will return to remote learning if the county reaches three
 (3) red metrics.
- School Enrollment
 - Current school enrollment is 1,450 students.
 - The school has received between 40 and 60 open enrollment applications, including applications for the second semester of the 2020-2021 academic year.
 - The school has received applications from students currently using Amphi Academy On-Line, and from students currently enrolled in the Marana and Tanque Verde School Districts.
- Dual Enrollment
 - Current dual enrollment classes include:
 - English Composition (5 sections).
 - College Algebra.
 - CTE.
 - U.S. History.
 - Biotechnology.
 - Human Anatomy, Physiology, Histology.
 - Spanish (on-line).
 - Economics (on-line).

- Expected to add 6 to 12 additional dual enrollment classes next year including:
 - Additional science.
 - Additional math.
 - Additional social studies.
 - Nursing.
 - Law.
 - Art.
- Master Schedule
 - Course list is currently posted and available.
 - Course selection is expected to occur in January.
- Graduation 2021
 - The school is trying to have Project Grad come back on campus in the Spring Semester to sell tickets.
 - The school has scheduled the Senior Parent Meeting for February 3, 2021.
- National Honor Society Virtual Tutoring
 - \circ $\,$ The school is reviewing ways to move to in-person tutoring in the Spring Semester.
